EXPRESSION OF INTEREST

ANKLESHWAR ASSET, ANKLESHWAR

ONGC, Ankleshwar Asset is operating Gandhar field located in Gujarat state. Gandhar field is about 60 to 70 Kms away from Ankleshwar town. It is a multilayered field having clastic reservoirs consisting of thirteen sands designated as GS-0 to GS-12 from bottom to top in the Hazad member of Ankleshwar formation. GS-12 sand corresponds to the top of Hazad member and marks the end of the deltaic deposition. It is overlain by the regionally developed Kanwa shale. The field is on continuous production since 1986. Water injection is the main energy replenishment mechanism in all the major reservoirs. The recovery at the field level is about 28%.
